Application is invited from the officers under the Central/State Government/Undertaking/Universities/Recognized Research Institutions/Semi Govt./ Autonomous and Statutory Organizations for filling up one post of Senior Architect in the pay scale of Rs.12,000-375-16,500(Pre-revised) Group 'A' (Gazetted) in the Andaman Public Works Department on deputation basis.

THE ELIGIBILITY CRITERIA FOR SENIOR ARCHITECT ARE AS UNDER:-


- (a) (i) The applicant should hold analogous post on regular basis; Or (ii) With 5 years regular service in the scale of pay of Rs.10000-15200/- Or equivalent in the Parent Cadre/Department. **AND,**
- (b) (i) Possessing Degree in Architecture from a recognized university or equivalent. (ii) 10 yrs professional experience. (iii) Should be registered with Council Architecture

The departmental Officers in the Feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationist shall not be eligible for consideration for appointment by promotion.

The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on closing date of receipt of application.

The period of deputation(ISTC) including the period of deputation(ISTC) in another ex-cadre posts held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not to exceed 4(four) years.

The incomplete application and the application received after due date will not be entertained.
