- iv) Interested candidates shall be ready to work in remote / hard areas as and when directed and also may have to travel to remote/hard areas as required.

- vi) The engagement will be as per the guidelines of respective NRHM programme under District Health Society (SA) on Contract basis for period of 11 months from the day of signing the contract within the stipulated period as per the offer of appointment letter.
