1. **Name of the Post** : GENERAL DUTY MEDICAL OFFICER

2. **Essential qualification** :

(i) A recognized MBBS degree included in the First or Second Schedule or Part-II of the Third Schedule (Other than licentiate qualifications) to the Indian Medical Council Act 1958. Holder of educational qualifications included in Part II of the Third Schedule should also fulfill the condition stipulated in sub section (3) of Section 13 of the Indian Medical Council Act 1958.

(ii) Completion of compulsory rotating internship

3. **Age Limit** : Below 70 years

4. **No. of Post** : 01 (One)

5. **Remuneration** : Rs. 40,500 P.M (Fixed) + Hard Area Allowance (as per the contract) + accommodation

6. **Terms & Conditions** :-

- i. The engagement is for a period of 11 months from the day the applicant signs the contract within the stipulated period as per the offer of the appointment letter. Any extension or renewal of appointment beyond this duration, if any, will be subject to a review of earlier performance and contribution in work and an agreement on terms that must be mutually agreed upon. However this would not be construed in any manner to be a promise for regular appointment under the India Reserve Battalion, A & N Islands.
- ii. Emoluments of the respective Post(s) are fixed as per details given above and no other allowance/claim by whatsoever name, including D.A., is permissible to the post.
- iii. The selected candidate shall be entitled to 2½ days of leave for every completed month of duty, which can be accumulated but not encashed.
- iv. The place of joining shall be the Port Mout (HC) in Andaman Islands. Further place of temporary duty can be anywhere in Andaman & Nicobar Islands as assigned by the Commandant, IRBn.
- v. Timings for the duties shall be according to the place of duty or as decided by the Commandant, IRBn A&N Islands.
- vi. The District specific & State specific requirements as decided by the Commandant, IRBn, A&N Islands will be mandated in the job requirements.
- vii. The Commandant, IRBn reserves the right to terminate engagement without assigning any reason thereof after serving one month's notice or paying one month's salary without service of any notice. Similarly the right to resign from the post by serving one-month's notice or by depositing one-month salary without serving notice to the Commandant, IRBn will be available to the selected candidate as well.
- viii. If it is discovered at any stage that any wrong information or false documents have been furnished based on which selection has been made, the Commandant, IRBn reserves the right to terminate the services forthwith, besides taking recourse to other legal proceedings.
