Applications are invited from the Eligible local candidates whose names are registered in the Local Employment Exchange **for engagement of Heavy Vehicle Drivers / Bus Drivers on Daily Wage basis** for a period of 06 (six) months in this Directorate of Transport, A & N Administration, Port Blair, as per the details given below :-

1.	Name of the Post :	Heavy Vehicle Driver / Bus Driver on Daily Wage basis.
2.	Age :	For Male 18 – 33 years. For Female 18-38 years <u>Note:</u> The crucial date for determining the age limit shall be the closing date of receipt of application from candidates/name from the Employment Exchange, A&N Islands.
3.	Qualification :	<u>Essential:</u> 1. Pass in Secondary School Examination (10 th Std) or its equivalent from a recognized board/Institution. 2. Must possess valid Professional Heavy Vehicle Driving License (PSV). 3. Atleast 03 (three) years experience in driving Heavy Motor Vehicle. 4. Should qualify in the Trade Test to be conducted by duly constituted selection committee. <u>Desirable:</u> 1. Knowledge of Motor Mechanism and capable to locate and rectify minor defects in the vehicle. 2. Should possess knowledge in Hindi.
4.	Rate of wages :	Rs. 284/- per day per head for North, Middle & South Andaman District and Rs.309/- per day per head for Nicobar district for 8 hours work in a single stretch or in two spells.

1. The candidates eligible for the posts are required to apply in the prescribed proforma together with attested copies of educational qualification, age proof, live employment registration card, Local/Category certificate, experience certificate, valid driving license and other testimonials etc with 2 (two) copies of passport size photographs addressed to the Director of Transport, Andaman & Nicobar Islands, Port Blair and should reach this Office **latest by 15.10.2012**.
2. One passport size photograph duly self attested should be pasted at the top right hand corner of the application filled in by the applicant.
