RECRUITMENT FOR THE POST OF FOLLOWER CONSTABLE COOK (EXECUTIVE) IN ANDAMAN AND NICOBAR POLICE

Applications are invited from eligible candidates for the post of Follower Constable (Cook) in Andaman and Nicobar Police. The number of post, scale of pay and eligibility conditions are given below: -

1. Name of Post – Follower Constable -Cook (Executive)

- i) **No. of Vacancies:** 2 (1 vacancy for General & 1 vacancy is reserved for ST candidates of A & N Islands)

Note: Vacancies may increase or decrease depending upon the requirements at the time of final selection.

2. **TRADE TEST/INTERVIEW**

Candidates who qualify in the physical measurements will be tested for aptitude and efficiency in the respective trades and marks would be allotted in accordance with their performance in the trade test and then interview, subject to maximum marks indicated in post as under.

3. Trade Test:-

iii.	Proper cleaning ness of utensils	05 Marks
iv.	Cleaning ness of the place of the cooking	10 marks

4. INTERVIEW

The candidates who qualify in the trade test will be subjected to an interview of 10 marks by a selection board.

5. HOW TO APPLY

- i) Candidate may submit their application on a plain paper in the format given below along with the self attested copies of certificates of age proof, OBC category, education qualification and copy of experience certificate with three passport size photographs (one should be affixed in the space given in the application form and other two should be attached along with application form) to **Dy. Superintendent of Police (Estt), Police Head Quarter, Atlanta Point, Port Blair** on any working day with effect from 25/03/2013 to 15/04/2013.

The submission of any forged document shall entail the registration of a criminal case.

6. Closing Date

Application form should be deposited in the above designated offices latest by 1700 hrs on 15/04/2013.

7. Instructions in General

- i) After scrutiny and acceptance of the application forms, each applicant will be issued an Admit card, which will be required at all, stages of the recruitment. The Admit card should be collected by the candidate from 22/04/2013 to 23/04/2013 from Recruitment Cell, Police Head Quarter, Atlanta Point, Port Blair.
- ii) Original documents (Educational qualifications, age proof and sports/NCC) will be checked at the time of 'Interview'. The candidates, therefore, should bring these original documents/ certificates only at the time of interview.

- iii) Applications found incomplete in any form are liable to be rejected and no further correspondence will be entertained in this regard. No Admit Card will be issued in case the application is rejected.
- iv) Candidates failing at any stage will be eliminated at that stage itself.
- v) Candidates who do not qualify in the physical measurement will be rejected. The candidates who are not satisfied with the decision of the Recruitment Board concerning their Physical Measurements only may prefer appeal in writing in the prescribed format to the appellate authority on the same day.
- vi) Benefit of ST would be given only to those candidates who belong to the ST category as notified by the Andaman and Nicobar Administration.
- vii) The date, time and venue of Physical Measurement shall be communicated in due course through local newspapers, All India Radio etc.
- viii) No TA or DA will be paid to the candidates for attending the selection process or Interview.
