

RECRUITMENT NOTICE

RECRUITMENT FOR THE POST OF FOLLOWER MESSENGER IN ANDAMAN AND NICOBAR POLICE RADIO

Applications are invited from eligible candidates for the post of Follower Messenger in Andaman and Nicobar Police Radio. The number of post, scale of pay and eligibility conditions are given below: -

1. NAME OF POST: - FOLLOWER MESSENGER

- i) **No. of Vacancies:-** 03 (02 vacancies for General & 01 vacancy is reserved for OBC candidates of A & N Islands)

Note: Vacancies may increase or decrease depending upon the requirements at the time of final selection.

- ii) **Pay Band + Grade Pay:-** PB-I Rs.5200-20200 + Grade Pay Rs.1800/-

iii) Eligibility Conditions:-

a)	Age limit (As on 15/09/2014)	i) 18 to 33 years for General male ii) 18 to 36 years for OBC male iii) 18 to 38 years for female (Relaxable by 5 years for Govt. Servants in accordance with the instructions issued by the Central Government from time to time).

2. PHYSICAL ENDURANCE TEST

The candidates who qualify after physical measurement shall undergo a physical endurance test as per the following standards:-

i) RACE

i.	(Male)	1 mile in 7 minutes
ii.	(Female)	½ Mile in 5 minutes

3. TRADE TEST

Candidates who qualify in the Physical Measurement and Endurance Test will be required to qualify in the trade test of 85 marks, which will include: -

i.	Bicycle/Motor Cycle Riding	50 Marks
ii.	Maintenance of Bicycle/Motor Cycle	35 Marks
	Total	85 Marks

The candidates who obtain 50% or more marks will be considered qualified in the trade test.

4. INTERVIEW

The candidates who qualify in the trade test will be subjected to an interview of 10 marks by a selection board. The appearance of the candidates before the Interview Board shall be compulsory. Those who do not appear before the interview will not be considered in the final selection, irrespective of their performance in physical and trade test.

Apart from this, additional marks up to a maximum of 5 marks shall be awarded for achievements in Sports and NCC as follows:-

a) NCC 'C' Certificate	:	2 marks
b) NCC 'B' Certificate	:	1 mark
c) Gold medal at National level in sports	:	3 marks
d) Silver medal at National level in sports	:	2.5 marks
e) Bronze medal at National level in sports	:	2 marks
f) Gold medal at State level in sports	:	2 marks
g) Silver medal at State level in sports	:	1.5 marks
h) Bronze medal at State level in sports	:	1 mark

Candidates should bring all their original certificates regarding their achievements in Sports and NCC at the time of interview.

On the basis of vacancies at the relevant time a final list of successful candidates shall be prepared on the basis of the marks obtained in the trade test, NCC/Sports marks and interview.

5. HOW TO APPLY

- i) Candidate may submit their application on a plain paper in the format given below along with the self attested copies of certificates of age proof, OBC category and education qualification with three passport size photographs (one should be affixed in the space given in the application form and other two should be attached along with application form) **to Dy. Superintendent of Police (HQ), Police Head Quarter, Atlanta Point, Port Blair on any working day with effect from 15/09/2014 to 15/10/2014.**

The submission of any forged document shall entail the registration of a criminal case.

6. CLOSING DATE

Application form should be deposited in the above designated office latest **by 1700 hrs on 15/10/2014.**

7. INSTRUCTIONS IN GENERAL

- i) After scrutiny and acceptance of the application forms, each applicant will be issued an Admit card, which will be required at all, stages of the recruitment. **The Admit card should be collected by the candidate from 01/11/2014 to 15/11/2014 from Recruitment Cell, Police Head Quarter, Atlanta Point, Port Blair.**
- ii) Original documents (Educational qualifications, age proof, sports/NCC and OBC certificate) will be checked at the time of 'Interview'. The candidates, therefore, should bring these original documents/ certificates only at the time of interview.
- iii) Applications found incomplete in any form are liable to be rejected and no further correspondence will be entertained in this regard. No Admit Card will be issued in case the application is rejected.

- iv) Candidates failing at any stage will be eliminated at that stage itself.
- v) Candidates who do not qualify in the physical measurement will be rejected. The candidates who are not satisfied with the decision of the Recruitment Board concerning their Physical Measurements only may prefer appeal in writing in the prescribed format to the appellate authority on the same day.
- vi) Benefit of OBC would be given only to those candidates who belong to the OBC category as notified by the Andaman and Nicobar Administration.
- vii) The date, time and venue of Physical Measurement shall be communicated in due course through local newspapers, All India Radio etc.
- viii) No TA or DA will be paid to the candidates for attending the selection process or Interview.
